Scholars have long held that modern racial health disparities are rooted in centuriesold systemic racism in America's policies and practices. As a result, medical and nonmedical inequities emerged and persist to this day. Now, more than ever, racial health disparities need to be addressed.

Despite recently released <u>data from the CDC</u> that life expectancy has improved overall, the story remains dire for Black Americans throughout the country. Whether it's maternal health, heart disease, cancer, nephritis or stroke, Black Americans are dying prematurely and at higher rates than white people and other minority groups.

April is <u>National Minority Health Month</u>, a program of the NIH's <u>National Institute on Minority Health and Health Disparities</u>. The 2024 theme is "Be the Source for Better Health: Improving Health Outcomes Through Our Cultures, Communities and Connections."

The National Black Caucus of State Legislators unequivocally supports the efforts of the NIH. As state legislators, NBCSL members are in prime position to not only raise awareness and address health disparities but to also take steps to improve the health of Black Americans and other racial and ethnic minorities we represent in our respective districts.

Since 1977, the National Black Caucus of State Legislators has consistently focused on health and human services policies and resolutions. Our 2024 resolutions were no different. This National Minority Health Month, NBCSL created a toolkit to help all members be their community's source for better health. On April 4-6, NBCSL legislators and corporate round table members gathered in Houston, Texas, for their respective business meetings, graciously hosted by Senator Borris Miles (TX), Chair of NBCSL Region X. The 3-day gathering highlighted the state of the organization and emphasized a renewed focus on collaboration and the work ahead. In addition to addressing organizational matters, the event featured crucial discussions on healthcare. Two pivotal panel discussions highlighted key issues surrounding health equity.

The first panel, "Prescription Drug Affordability Boards (PDABs) and Health Equity," moderated by Senator London Lamar (TN), featured Dr. Maisha Standifer, Director of Health Policy, Satcher Health Leadership Institute, Morehouse School of Medicine; Melissa Gong, Executive Director of the Global Coalition on Aging; and Maimah Karmo, Founder, Tigerlily Foundation. They delved into the evolving landscape of PDABs and their impact on prescription drug accessibility. Noteworthy questions from legislators, including Representative LaKeshia Myers (WI), sparked discussions on improving healthcare representation and diversity within PDABs.

The second panel, "Immunizations and Health Equity," moderated by Representative Rhetta Bowers (TX), featured Senator Raumesh Akbari (TN), Vice President, NBCSL; Dr. Candice Robinson, Director of Scientific Affairs and Public Health, GSK Vaccines; Dr. Frank North, Assistant Professor, Irma Lerma Rangel School of Pharmacy, Texas A&M University; and Terri Burke, Executive Director, Immunization Partnership. Discussions ranged from the importance of vaccines in eradicating diseases like Measles to innovative strategies for equitable vaccine access. The panelists addressed challenges such as vaccine misinformation and politicization, emphasizing the role of legislation and accurate messaging in promoting vaccination.

The event concluded with engaging Q&A sessions, highlighting the need for proactive measures to combat misinformation and advocate for vaccine distribution. Representative Bowers led insightful discussions on overcoming challenges posed by social media and politics in immunization efforts, emphasizing the importance of engaging constituents and providing factual information.



LEGISLATION IN PROGRESS

Expanding Specialized Treatment for Sickle Cell Disease

In a groundbreaking development, Florida has allocated a staggering \$10 million toward expanding treatment options for sickle cell disease. This significant investment marks a pivotal moment in healthcare, offering hope and relief to countless individuals affected by this debilitating condition.

With this funding, specialized treatment centers across the state are set to receive substantial resources, empowering them to enhance care, research and outreach efforts. From cutting-edge therapies to improved patient support programs, the impact of this initiative promises to be farreaching.

As highlighted in NBCSL resolution HHS-23-27, NBCSL represents communities and states across the country most affected by sickle cell disease and believes that institutions should provide high quality, evidencebased care for individuals living with sickle cell disease as well as potential opportunities to improve care, outcomes, and cost-effectiveness of care. We support expanded funding that would provide access to all medications and forms of treatment for sickle cell disease, and services for enrollees with a diagnosis of sickle cell disease that are eligible for coverage under Medicare and Medicaid programs.

FEATURE STORY Maternal Mortality: Black Mothers Are Under Attack

America's maternal mortality rates are among the highest in the developed world, and the rates are especially high among Black mothers who are unjustly and unfairly dying at crisis proportions.

Since at least 2014, Black women have had the highest maternal mortality rate of any racial or ethnic group, per <u>USAFacts.org</u>. According to the CDC, Black women die from complications related to pregnancy at roughly two to three times the rate of white, Hispanic, Asian American and Pacific Islander women—regardless of their income or education levels.

Now, more than ever, America needs to make Black maternal health a national priority. Black Maternal Health Week began in 2017 as an effort by the <u>Black Mammas</u> Matter Alliance (BMMA) to raise awareness about Black and minority health issues. In 2021, President Biden signed the first-ever <u>proclamation</u> marking Black Maternal Health Week (April 11-17) and bringing critical attention to the country's escalating maternal mortality rate.

While the Biden-Harris administration has made considerably more effort than any other previous administration in addressing the maternal health crisis by investing hundreds of millions of dollars and directing government agencies to come up with <u>deliberate and actionable</u> plans, there is still much more work to be done. After all, maternal mortality is not just a medical issue; rather, it stems from deep-rooted racism that has medical and non-medical implications.

The <u>Commonwealth Fund reports</u> that "states are exploring and implementing policies that affect postpartum care, midwives, doulas and freestanding birth centers. Individual policies can support evidence-based practices, but such

policies are not a checklist for advancing birth and perinatal health equity. These individual policies are single elements needed to support systemwide transformation."

"Caring for the health and well-being of Black mothers is not just a matter of policy; it is a moral imperative," says Senator London Lamar, Chair of NBCSL's Health and Human Services Committee. "We cannot rest until every Black mother receives the care and support she deserves. free from the burden of racism and inequality. Together, we must advocate for systemic change and invest in initiatives that prioritize the health and safety of Black mothers and their babies."

NBCSL remains committed to doing its part to transform the system by ensuring equitable health outcomes (HHS-24-36) and encourages members to review stateby-state comparisons of perinatal policy and work with local governments to create structural policy changes and communityled solutions to help address the underlying causes and address the plight of America's Black mothers.

Stop Book Bans: Combating Censorship in Schools and Public Libraries

Since 1985, the <u>American Association of School Librarians</u> has recognized <u>School Library Month</u> in April. Meant to be a time for school librarians to celebrate the essential role that strong school libraries play in transforming learning, they are instead on the front lines alongside public librarians and educators fighting hard against book bans that are sweeping across the nation.

The <u>American Library Association (ALA)</u> recently <u>released new data</u> showing a record 4,240 unique book titles were targeted for censorship in 2023, a 65% increase over the 2,571 unique titles targeted in 2022 and a staggering 128% increase over 2021 numbers.

"Their aim is to suppress the voices of those traditionally excluded from our nation's conversations, such as people in the LGBTQIA+ community or people of color," said Deborah Caldwell-Stone, director of ALA's Office for Intellectual Freedom. "Each attempt to ban a book by one of these groups represents a direct attack on every person's constitutionally protected right to freely choose what books to read and what ideas to explore."

<u>PEN America</u>, a nonprofit organization that tracks all <u>book bans</u> in libraries and classrooms across the U.S., reports 37% of banned books include characters of color or discuss race and racism since July 2021. In addition, authors whose books are

targeted are most frequently female, people of color and/or LGBTQ+ individuals.

According to PEN America, more than half of America's states banned books during the 2022-2023 school year. While more than 40% of all book bans occurred in Florida, there were 625 banks in Texas, 333 bans in Missouri, 281 bans in Utah and 186 bans in Pennsylvania. In addition, ALA reports that more than 100 titles were challenged in 17 different states in 2023.

"These numbers are astounding, and as members of the National Black Caucus of State Legislators, we should all be alarmed by the efforts to erase our history and our voices," said Alabama State Representative and NBCSL President Laura Hall. "We must do everything we can to ensure our students' right to choose and read books in schools, classrooms and public libraries is preserved in perpetuity."

A <u>2023 Ipsos poll</u> found that most Americans, regardless of party affiliation, say they support teaching about the history of slavery, racism and segregation in public schools. As such, NBCSL urges you to encourage your constituents to contact you and report a book challenge or attempted ban, or upcoming library or school board meetings. LEGISLATOR SPOTLIGHT Rep. Sandra Hollins (UT)

Sandra Hollins holds the distinction of being the first Black American woman elected to the Utah State Legislature. She currently serves as the Assistant Minority Whip and also assumes the role of Vice Chair on the Executive Office and Criminal Justice Appropriation Committee.

Her noteworthy legislative accomplishments include successfully championing legislation aimed at banning the use of knee-on-the-neck restraints by law enforcement, implementing cultural training requirements for school resource officers, expanding job opportunities for individuals with prior incarceration experiences, eliminating provisions that allowed for slavery within the Utah state constitution, and officially recognizing Juneteenth as a state holiday.



In an inspiring collaboration, the Quad Caucus convened with voting rights activist Stacey Abrams to pledge their unwavering support for her efforts to address the challenges faced in advancing the Diversity, Equity and Inclusion (DEI) agenda. Representing the Black, Hispanic, Native, and Asian-Pacific communities, Quad Caucus leaders vowed with resolute determination to unite to combat the work ahead, which includes validating their expertise and knowledge of the problem, preparing for opposition, and pursuing legal action for change.

"The issue of Diversity, Equity and Inclusion (DEI) has reached a critical juncture with far-reaching implications," says NBCSL President Laura Hall. "From disparities in access to education and employment opportunities to unequal treatment within the criminal justice system, and even in healthcare, the effects of these entrenched inequalities are keenly felt by marginalized groups." Compounding these challenges is the alarming trend of more than 30 states introducing bills aimed at banning or limiting DEI initiatives in their current legislative sessions. These legislative efforts threaten to roll back hard-fought gains in promoting diversity and fostering inclusive environments. They not only undermine efforts to address historical injustices but also hinder the advancement of equitable policies and practices essential for building a more just and inclusive society.

The members of the Quad Caucus acknowledge the challenges ahead as they confront discriminatory legislation and corporate hesitancy to endorse DEI principles. Together, they are ready to take bold and public action, shedding light on those who impede DEI progress. NBCSL will be following this closely and will share updates as the Quad Caucus progresses.
